Welcome to the winter installment of the FeganScott firm newsletter – and to 2023.

As we begin another year, it provides an opportunity for us to reflect on the work that our attorneys have undertaken – and the successes we've delivered – on behalf of our clients in 2022.

Last year was filled with important cases. Examples of our work for consumers include a \$92 million data privacy settlement with TikTok, a pending settlement valued in excess of several hundred million dollars for Hyundai and Kia vehicles at risk of catching fire, and ongoing litigation to halt racial discrimination by the NCAA impacting Black student-athletes. Another example is our advocacy on behalf of survivors of sexual assault and harassment. Co-founder Beth Fegan represented the First Partner of California and a professional ballerina who testified against Harvey Weinstein about their sexual assaults in his California criminal trial, and our firm recently filed charges against the City of San Antonio on behalf of female maintenance workers who were targeted by male supervisors with sexual harassment, age discrimination, and physical abuse.

Each of these cases, along with the many others that we're currently working on, are illustrations of FeganScott's mission to initiate positive change to make the world a safer place.

We often hear from our clients how much they appreciate the work we do, and how much our advocacy on their behalf means, which is very heartening for us. Another powerful testament to the quality and importance of our work is when it is recognized by our peers.

### Harvey Weinstein Found Guilty of Rape in Los Angeles Trial

FeganScott has a long history of representing victims of sexual assault. We represented a group of women who brought a class action lawsuit against Harvey Weinstein, ultimately resulting in confidential settlements for dozens of women, and continue to represent victims who stepped forward in his recent criminal trial in Los Angeles.

Last month, the jury in the Los Angeles trial found Harvey Weinstein guilty of rape. As a result, he faces up to 18 years in prison, adding to the 23-year sentence that he is already serving for his 2020 New York rape conviction.

The women FeganScott's Beth Fegan represented for the Los Angeles trial include the First Partner of California (known as Jane Doe 4), one of the women for whom the prosecutors brought a charge for rape against Weinstein, and Ashley Matthau, a prior bad-act witness, a legal term for someone who can help establish a pattern of behavior, who testified regarding her assault to support the prosecution's argument that Weinstein engaged in a pattern of predatory behavior.

Beth also represented Louisette Geiss, who was a corroborating witness for Jane Doe 4 and separately, a lead plaintiff in the class action based on her own assault by Weinstein.

After the verdict was delivered, Beth shared this statement:

"Over the course of several weeks, eight amazingly courageous women faced their abuser, Harvey Weinstein. They stood up and shared terribly painful stories with the jurors, and endured attacks from the defense team intended to humiliate and shame them for their bravery. We are thankful that those jurors saw Weinstein for what he is – a serial predator.

"While we would have preferred that those jurors had found him guilty on all counts, we understand that it was a complex trial, made more difficult by the defense team's argument that a woman who is assaulted must forego her chosen career or be accused of consent after the fact.

"My client, Jane Doe 4, shared her story not with an expectation to testify but to support all the survivors who bravely came forward. While we are heartened that the jury found Weinstein guilty on some of the counts, we are disappointed that the jury could not reach a unanimous verdict on Jane Doe 4. She will continue to fight for all women and all survivors of abuse against a system that permits the victim to be shamed and re-traumatized in the name of justice.

"The bravery and courage demonstrated by these women will not be dimmed. Their heroic actions have ensured that Harvey Weinstein will likely spend the rest of his life in prison where he belongs, and that people like him understand the consequences of their actions."



Female Maintenance Workers File Charges of Sexual Harassment, Racial and Age Discrimination Against City of San Antonio

In November, FeganScott filed legal charges on behalf of two women against the City of San Antonio, alleging that supervisors at the Henry B. Gonzalez Convention Center created a sexually charged and toxic work environment by routinely targeting female maintenance employees with sexual harassment, age discrimination, and physical abuse.

According to the charges filed with the Texas Workforce Commission, Civil Rights Division, both women complained to management about the supervisors' inappropriate behavior, but their complaints were ignored.

"These women knew that when they came to work each day, they would likely face a barrage of harassment by their supervisors," said attorney Lynn Ellenberger, part of the FeganScott team representing the women who filed the complaint.

"We look forward to bringing real and lasting change to the city and, specifically, to the convention center on behalf of all the female maintenance workers," Ellenberger



FeganScott Investigating Several Automobile Manufacturers Over Alleged Safety Defects

Car defects pose serious hazards to drivers, passengers, and the public at large. Recently, FeganScott has launched several investigations into alleged vehicle defects against some of the largest automobile manufacturers in the world, including Mercedes-Benz and Nissan.

The Mercedes-Benz investigation relates to a potential defect found in vehicles equipped with an M247 engine that can lead to complete piston failure, forcing owners and lessees to pay for an engine replacement that could cost upwards of \$20,000.
